The French Government has released a fresh version 2018.P3.1 of the DSN technical book effective from Jan 2018 with updates to the prior version P3.2018.1. Note that this version is also called DSN P3.2018.1.1.

Details:

Note that while the version is the same, the version number is renamed differently as compared to the prior version. The new technical book (version 2018.P3.1) released for DSN Phase 3 contains changes / corrections made to the earlier released version P3.2018.1. This new version does not have many changes as compared to the prior one, yet they do have changes to the definition of new attribute definitions and datatype changes along with a few other changes. The analysis is in progress and the changes expected will be communicated soon. This version of the DSN norm will be effective from 1st January 2018. Oracle will deliver a combined solution considering the earlier version of DSN technical book (P3.2018.1)

Oracle PeopleSoft's patch details:

Required nodes and attributes will be versioned accordingly and necessary changes to its data types, definitions and descriptions, validations, and character length if any as required will be done and delivered

N4DS 2017

Executive Summary:

The French Government has released technical specifications for N4DS (Norme pour les Déclarations Dématérialisées Des Données Sociales) reporting.

Details:

The new N4DS technical book (V01X12) released and contains changes made to the earlier released version V01X11. Changes foreseen are around deletion, modification, and addition of a few datatypes and validations. Reporting using the N4DS norm may be the last this year considering the new norm DSN.

Oracle PeopleSoft's patch details:

Required nodes and attributes affected by the changes announced will be modified as required and delivered

DSN P3.2018.1

The French Government has released version P3.2018.1 of the DSN technical book with updates to the prior version 2017.P3.1.

Details:

The new technical book (version P3.2018.1) released for DSN Phase 3 contains changes / corrections made to the earlier released version 2017.P3.1. There are close to 147 data points mentioned in the differential document released. The analysis is in progress and the changes expected will be communicated soon. This version of the DSN norm will be effective from 1st January 2018.

Oracle PeopleSoft's patch details:

Required nodes and attributes will be versioned accordingly and necessary changes to its data types, definitions and descriptions, validations, and character length if any as required will be done and delivered

Expected Patch Availability:

Pay Impacts of the New Unemployment Insurance Agreement

Executive Summary:

The new unemployment insurance agreement signed by the social partners provides for several changes to the contributions. These will come into force, for the most part, on 1 October 2017.

Details:

A new unemployment insurance agreement was signed by the social partners. This agreement is established for a period of three years from October 1, 2017 to September 30, 2020. Though, the "basic" contribution is unchanged, the new unemployment insurance agreement creates a "temporary exceptional contribution" to be borne by the employer for all contracts falling within the scope of unemployment insurance.

Oracle is in the process of analyzing this change and will provide more details around the best solution that fits this requirement.

Legislative Changes Effective 1st January 2017 – Part 6

Annual legislative changes Part 6 consisting of 2 changes. These changes are effective from 1st January 2017.

Details:

As part of the multiple legislative updates that are announced during the end of each year, the Government of France has announced the changes that needs changes to be made in the system:

- 1. Benefit In Kind (Lodgment)
- 2. Meal Allowance Value

Prélèvement à la Source (PAS) - Deduction at Source

Target Audience:

Customers using Global Payroll for France

Executive Summary:

The French Government recently announced reporting requirement of Deduction at Source within DSN. While they are in the process of formulating a complete policy, the Deduction at Source is scheduled to come into force on 1 January 2018.

Details:

Note that any changes in the calculation rules for Deduction at Source (PAS) is yet not announced, and from the earlier announcements it is deemed to remain unchanged. The rate of tax is considered to be confidential and may be communicated directly by the Tax Collector. And the Deduction at Source amount will be paid monthly to the Tax Collector. Deduction at Source will necessitate reporting of the contribution via DSN. The details of impacted nodes/attributes along with the new nodes are communicated.

Oracle PeopleSoft's patch details:

Oracle is awaiting further information from French Government on this legislation. Yet the changes announced in the reporting will be developed by modifying the existing nodes/attributes and creating the new nodes appropriately.



Expected Patch Availability:

Oracle will delivered a patch for this change. And details and the timeline of the patch will be communicated after receiving complete details of the legislation
