- **Profile Management** - Development has been working on the Fluid Profile Search Match Compare feature and fluidizing actions for employee and manager self-service talent profile. Our next meeting will be August 25th to review Profile Search Compare and the enhancement for profile acknowledgment.
- **ELM** – This month, the focus group provided input on the new ELM Kibana analytics. The ELM team is finalizing development of LTI integration to allow integration with Zoom and other LTI compliant vendors.

- **United States** – The updated Fluid Voluntary Self-Identification of Disability 503 has been posted (effective 8/4/2020).
- **Switzerland** - Tax authorities will accept transmission done with Swissdec version 4.0 in 2021.
- **United Kingdom** – HM Revenue & Customs has published specifications for employer substitute form and PAYE draft forms of P60 for the fiscal year 2020-21.
- **Japan** - The Japan National Tax Agency has published a new template to be used for tax year 2020. Also, It has introduced the new Employee Type "Single Parent" which replaces the current Employee types "Special Widow and "Widower".
