#### JD Edwards : EU Electronic Invoice Solution


**JDE supports a common European Union Electronic Invoice solution**. The user can use JDE E1 Localizations to generate invoice details in XML format accordingly to the **UBL 2.1 standard** and process the response file received from the service providers. Users can modify this common e-invoice XML template with BI Publisher to comply with additional country-specific requirements.

**JDE also supports the upload of e-invoices in Accounts Payable.** The user can take advantage of JDE's standard base functionality to receive electronic invoices from suppliers and upload them in the system using PO411Z1 or custom programs.







#### E-invoicing in JDE Contract & Service Billing and Real Estate Management

JD Edwards customers shall generate einvoice XML files according to the EU UBL 2.1 standard from the JD Edwards "Contract and Service Billing" and "Real Estate Management" modules.

# Enrich E-invoicing data extraction to accommodate additional UBL 2.1 XML tags

JD Edwards customers shall use additional XML tags to handle country specific format requirements. At the same time Oracle will publish a new tutorial on how to customize e-invoice XML templates using BI Publisher.

#### **E-reporting in France**

Research

France will introduce an e-Reporting obligation with the implementation of mandatory B2B einvoicing. The transactions covered by e-Reporting will be B2C transactions, as well as nondomestic B2B transactions (both intra- and extra-EU).

The e-Reporting obligation follows the same timeline as the B2B e-Invoice. Several details related to the content of the e-Reporting and its technical standards have not yet been finalized by the French Government. Oracle is monitoring the progresses while researching possible solutions.


