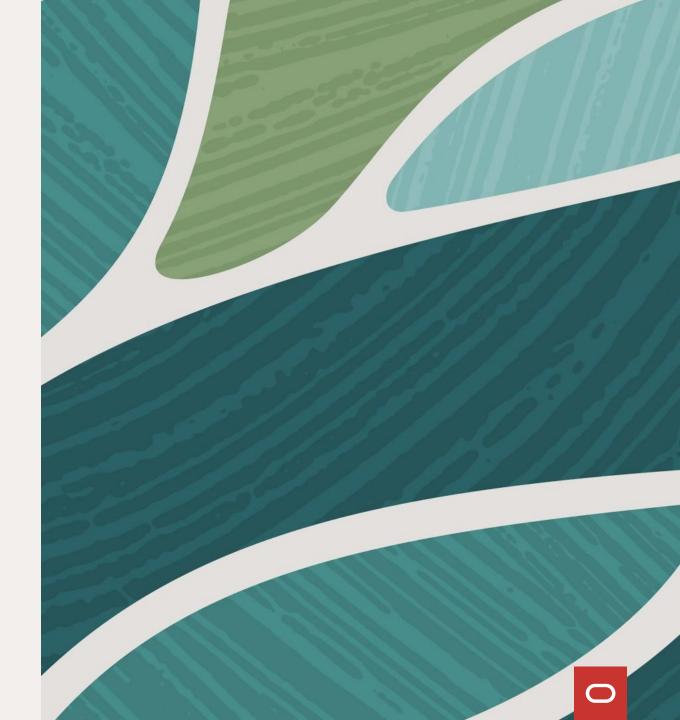

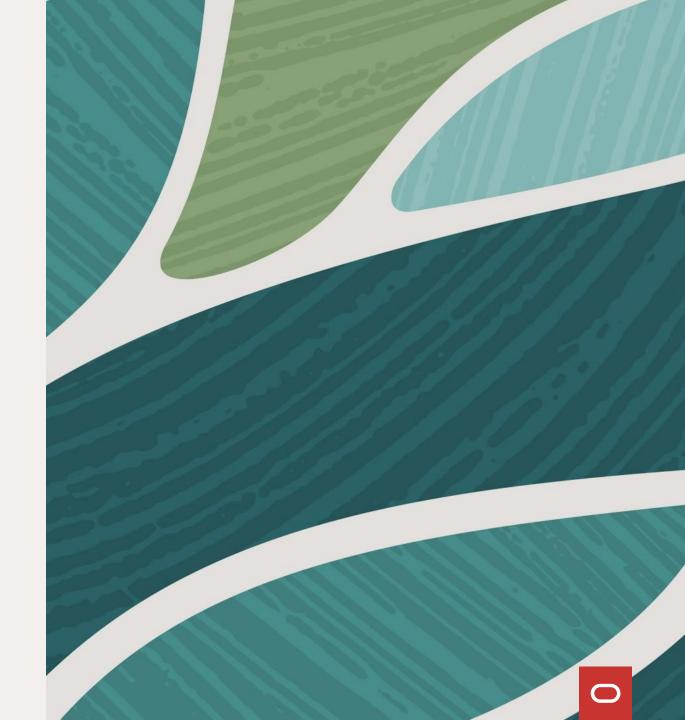

Regulatory Landscape in

France



France B2B E-Invoicing & E-Reporting mandate

The obligation to **issue electronic invoices** and submit **electronic reporting data** will take effect from:

- 1-Sep-2026, for large enterprises and intermediate-sized companies.
- 1-Sep-2027, for small and medium-sized enterprises (SMEs) and micro-enterprises

The obligation to receive electronic invoices will apply to all businesses starting from: 1-Sep-2026.

France B2B E-Invoicing & E-Reporting mandate

Electronic invoicing (E-Invoicing) applies to all **domestic operations:** sale and purchase transactions (including self-billing) of goods and/or services conducted between businesses established in France that are subject to VAT.

In addition, businesses are required to transmit specific information to the tax authorities through a process known as **E-Reporting** for commercial transactions that are not subject to electronic invoicing. This requirement primarily applies to:

- Businesses conducting trade with companies not established within the national territory (B2B international)
- Businesses subject to VAT in France that engage in transactions with individual consumers and, more broadly, with entities not subject to VAT (B2C)

The "cycle de vie" refers to the tracking and updating of invoice statuses throughout their lifecycle, including creation, transmission, validation, payment, and resolution of disputes, with real-time data reporting to tax authorities for compliance purposes.



France B2B E-Invoicing mandate – December 2024 Update

1. France transitioning to a PEPPOL-based Continuous Transaction Control (CTC) model

The Ministry of Finance (DGFiP) applied to become the official French PEPPOL Authority

2. Redefinition of the Public Invoicing Platform (Portail public de facturation - PPF):

- The PPF will no longer function as a free platform for issuing and receiving invoices
- It will focus on managing the recipient directory and acting as a data hub for tax reporting

3. Mandatory Use of Certified Platforms (Plateforme de Dématérialisation Partenaire - PDP):

- Businesses must use Certified Platforms (PDPs) for e-invoice transmission and e-reporting
- Direct connections to the PPF for invoice exchanges are no longer allowed

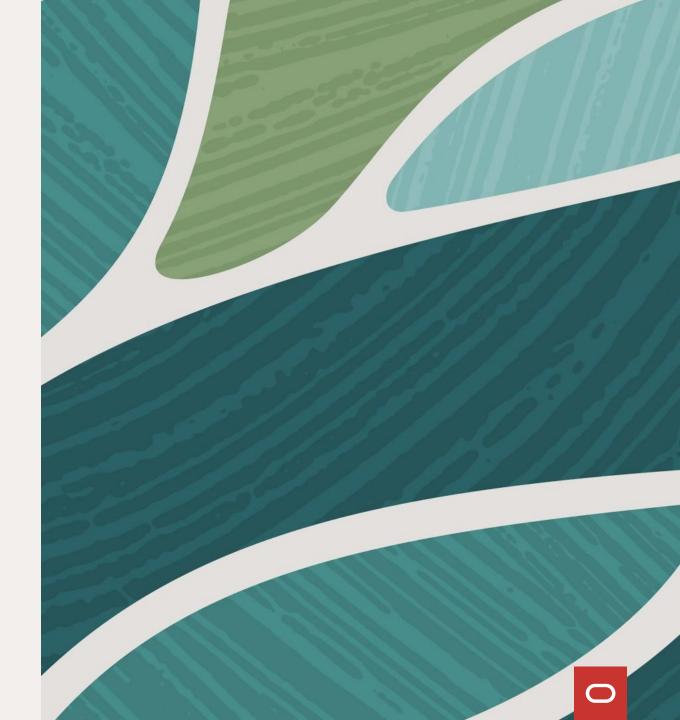
4. Updated Technical Specifications:

A new version of external specifications was released focusing on the PPF's limited role in directory management and E-Reporting

Oracle Global Strategy: E-Invoicing Enablement

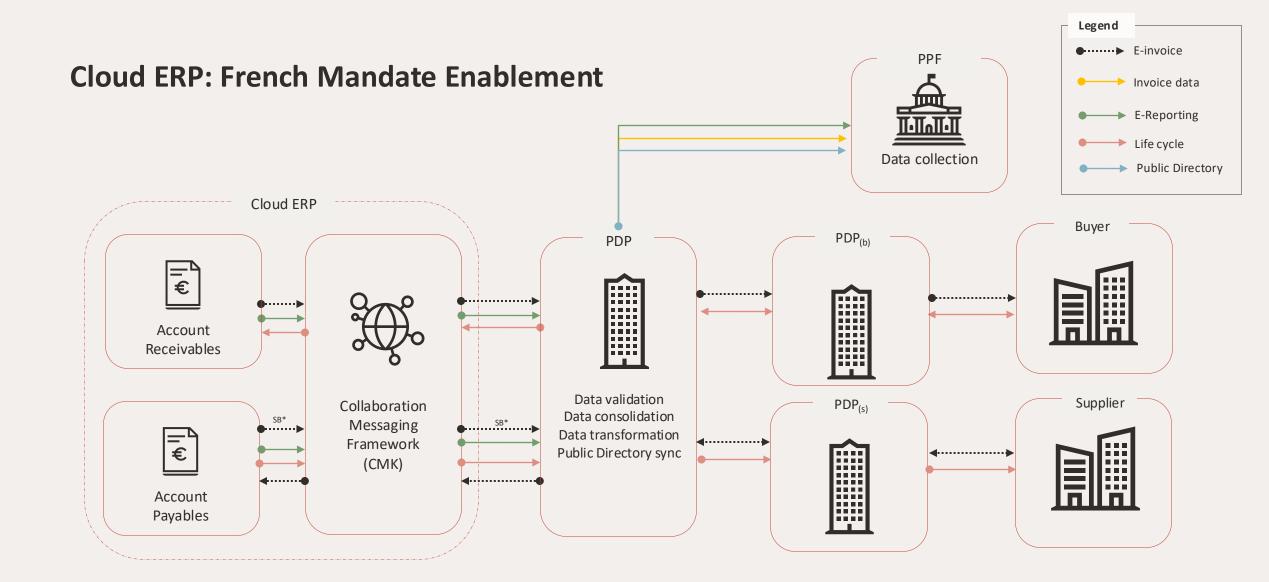
Product capabilities:

- Support for international data standards (UBL, PEPPOL BIS, PINT etc.)
- Comprehensive support for complex financial and fiscal scenarios across both domestic and international transactions
- Automated data validation and auditing
- Scalability and customization
- Secured and easy integration with PDPs

Integration with external 3rd parties (PDPs in France) to:

- Manage bi-directional communication with tax authorities and/or trading partners (securely)
- Perform data validation and cross checks with the public directory
- Allow E-Invoicing interoperability with other countries



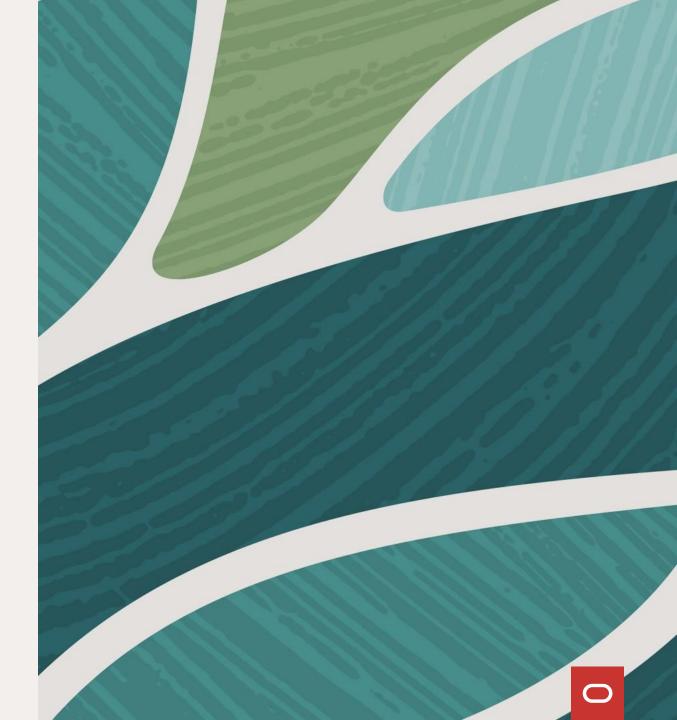

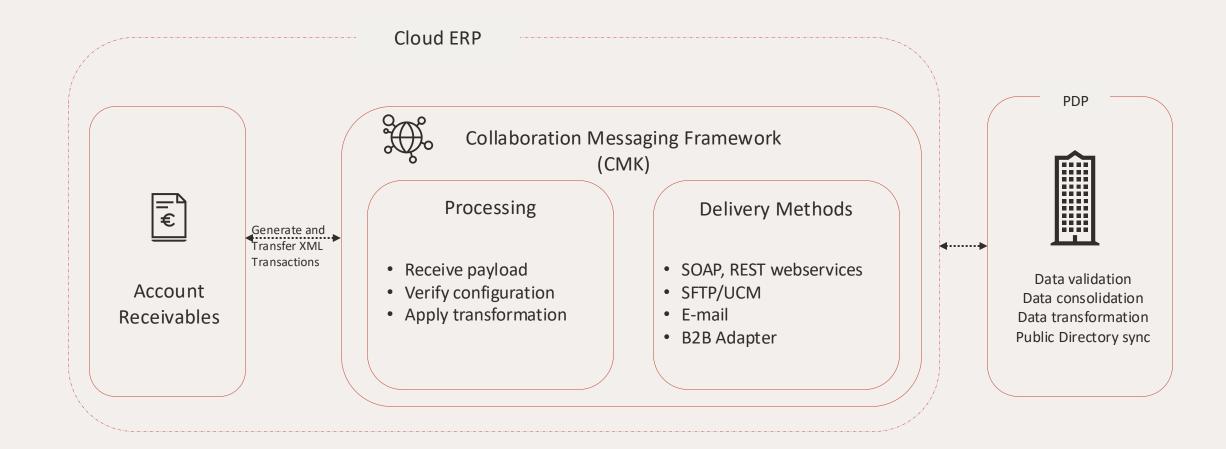


Cloud ERP: E-Invoicing features

- Out of the box support for UBL 2.1 E-Invoicing standard (mandated in France)
 - In release 24A the E-Invoicing dataset and template were enhanced to improve coverage of the French mandate requirements on top of EN 16931
 - In release 24C new GDFs were enabled to store fiscal identification numbers (SIREN, SIRET, routing code)
 - In release 25B: Improved support for advanced payments in AR
- 2. Configuration flexibility
 - The XML stylesheet is fully configurable
 - Additional data elements can be exposed through the AR extensibility feature
 - Standard codes and values can be mapped through Domain Value Maps (DVM)
- 3. Seamless integrations with PDPs
 - Oracle enables seamless PDP integration ("PDP agnostic") via standardized and extensible APIs
 - In release 25A REST webservices were added as a supported delivery method
- 4. Planned enhancements
 - CMK: Simplified customer and supplier setup/onboarding

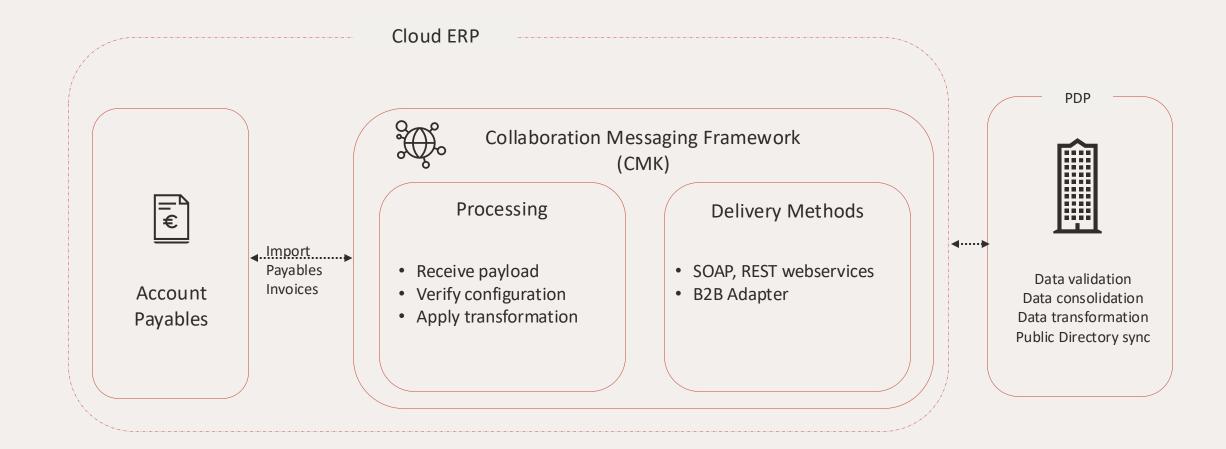


Cloud ERP: E-Invoicing outbound flow





Cloud ERP: E-Invoicing inbound flow



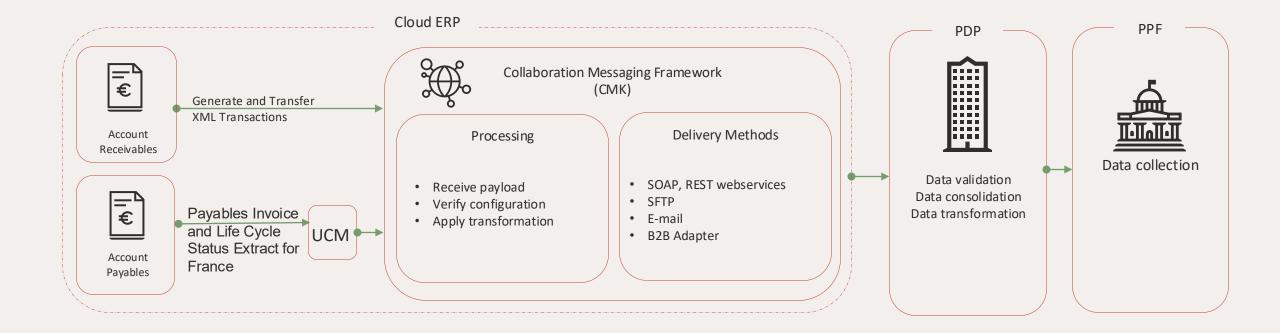


Cloud ERP: E-Reporting features

- Oracle Receivables
 - Outbound transactions eligible for e-reporting are issued using the same streamlined process as domestic
 E-Invoicing
- Oracle Payables:
 - A new feature ("Payables Invoice and Life Cycle Status Extract for France") enables the automated extraction and generation of individual XML files for each import invoice
 - The feature also supports the generation of self-billing XML files, which are classified and processed as einvoices
 - Seamless integration with CMK, allowing for submission status update processing
- 3. Out of the box support for UBL 2.1 E-Invoicing standard

Cloud ERP: Life cycle features

Oracle Receivables

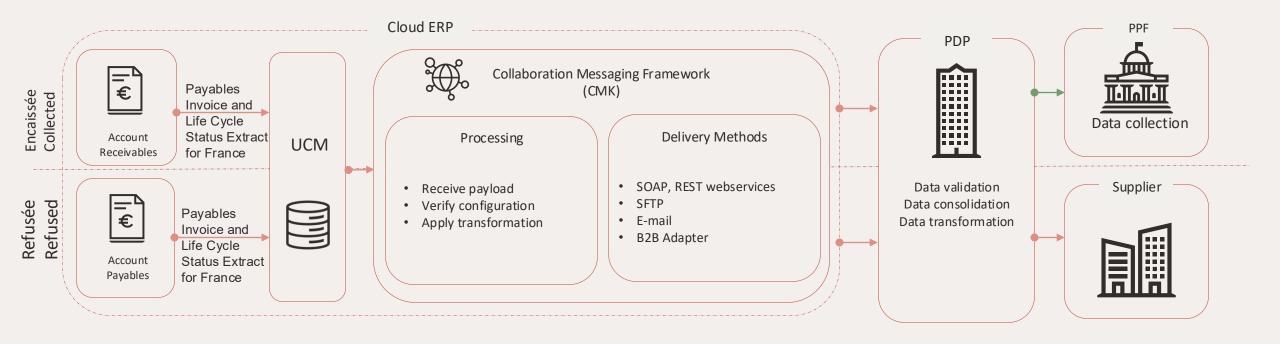
- The program extracts all receipt applications (and un-applications) associated with receivables invoices with lines that have tax point date set to "Payment"
- The output file generated by the program is in the CDAR format

2. Oracle Payables:

- The program will extract all invoices that have assigned a "refused" type hold
- The output file is generated in the UBL Application Response format (planned for future release)
- Seamless integration with CMK, allowing for submission status update processing



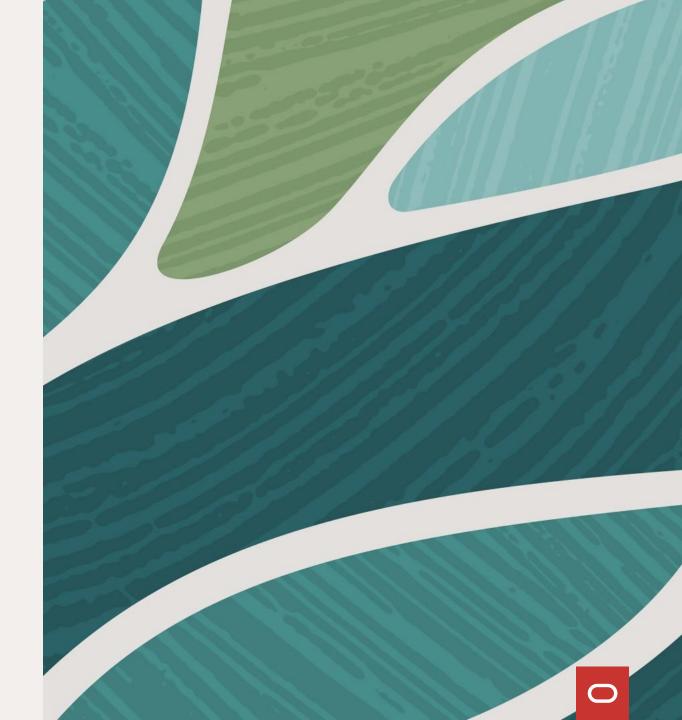

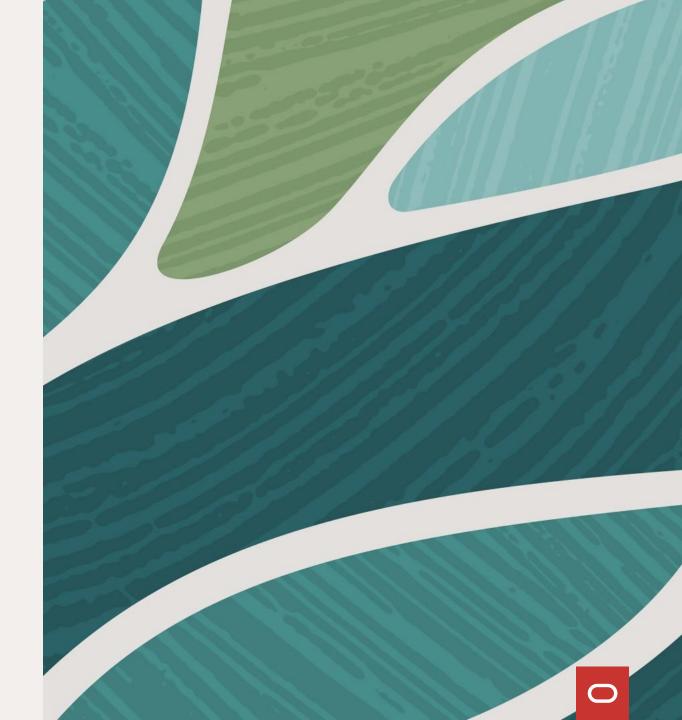

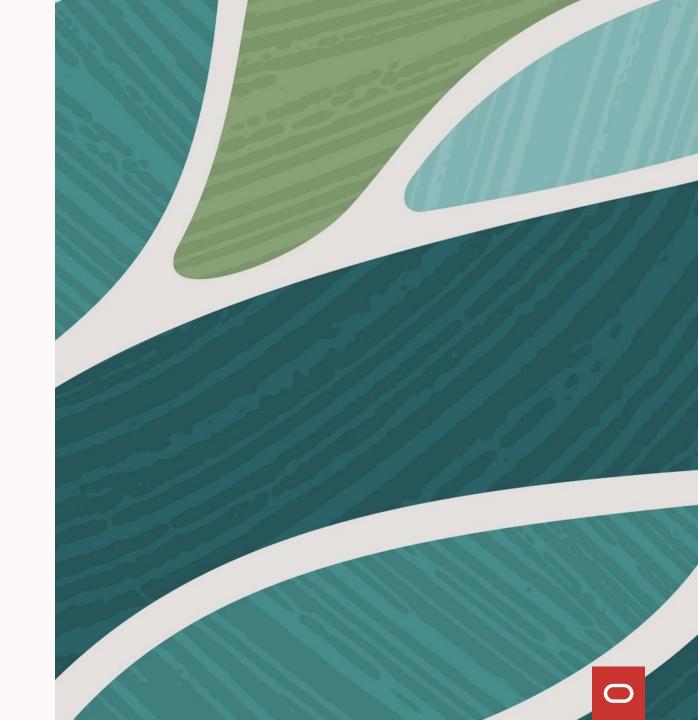
